The 2017 Annual Meeting will mark the end of my tenure as a Board Member for the Tuscola Community Foundation. I have been honored to serve this great organization, and I welcome the new board members and leadership team that will be selected during the annual meeting. What a testament to our great community that there are always others willing to step forward and serve!

The Fiscal Year that ended on June 30, 2017 saw incredible growth in interest, dividends, and investment gains, further strengthening the financial position of TCF. Donations to the organization also increased by over 70%, thanks in large part to a new scholarship fund created by the Harriet Bell Trust. This new fund will provide scholarships to Tuscola students pursuing degrees in Library Sciences.

TCF continues to provide scholarships to Tuscola students through its various funds, increasing awarded scholarships to \$6,000 for the most recent school year. In the past year, we have collected and provided nearly \$20,000 to finish the Imagination Station Playground project, a collaborative effort with the City of Tuscola and the Tuscola Rotary Club. TCF also funded a portable oxygen concentrator for use by elderly residents while traveling.

I hope each of you can attend the Tuscola Community Foundation Annual Reception on September 19, 2017 at Ironhorse Golf Club. One of Tuscola's most distinguished former residents, vocalist Andrea Huber, will be sure to delight and amaze with her talents and reflections on her hometown.
